The Aviation Working Group (**AWG**) held an important African regional event on the Cape Town Convention and its Aircraft Protocol (**CTC**) and cross border transferability of aircraft (XBT).

This AWG event was hosted by, and held in association with, the South African Civil Aviation Authority (**SACAA**), with the support of the International Civil Aviation Organization (**ICAO**) and the International Institute for the Unification of Private Law (**UNIDROIT**).

It was held in Cape Town, South Africa at the **Westin Hotel, Cape Town** – located at **Convention Square, Lower Long Street**, Cape Town, South Africa – on 19 & 20 June 2018.

The program addressed the economic benefits of CTC, including links with the interpretation and implementation of, and compliance with, its provisions, as well as regional and global CTC developments.
