



JOINT AWG - AVIARETO TASK FORCE ON ACCEPTANCE, USE AND DELIVERY OF DIGITAL SIGNATURES

In view of the need, made clear by the disruptions caused by the spread of COVID 19, to accelerate the use of digital signatures (**DS**) on legal and other documents affecting aviation leasing, financings and registration (and related regulatory documents), AWG and AVIARETO have agreed to -

Create a task force (DSig – TF) to explore options, and, if possible, propose <u>a global approach or system</u> for the acceptance, use, and efficient delivery of DS to the industry and government officials

This DSig – TF will build on the prior work on DS by AWG in creating (with FEXCO) the GATS trading platform and by AVIARETO in creating and operating since 2006, the Cape Town Convention International Registry.

Other key players, *including major aviation regulators and authorities*, will be invited into the DSig – TF, as needed.

Core objectives of the work of the DSig - TF and any resulting approach or system are as follows -

- Providing a global approach or system, which may include use of a platform, to be recognized by authorities and as a matter of law or practice around the world
- Providing highest level participation (on-boarding) procedures, taking advantage of AVIARETO's 14 years of tested aviation-industry vetting process
- Providing highest level IT security, and appropriate authentication, and verification procedures
- Providing execution, consent, and delivery mechanics geared to the needs of the aviation industry, which may include use of an escrow or closing-type facility as used in the Cape Town Convention International Registry and/or GATS
