

## Status of CTC compliance index watchlist notices – 15 December 2020

Watchlist notices provide an outlook on scoring with reference to the contracting state’s existing score rather than CTC compliance *per se*. For example, where the affected variable is low in a contracting state, a further non-compliant development will be assigned a ‘confirmatory’ outlook. Once a contracting state is placed on the CTC Compliance Watchlist, AWG will closely monitor ongoing developments and issue reports on a regular basis with fact-based, events-driven updates.

Placement on the CTC watchlist may **not** be indicative of negative compliance activity. Please read the corresponding watchlist notice to look at the compliance assessment and material developments.
